### Practice Profile

Steven also represented one of the 47 defendants (known as the “Hong Kong 47”) charged with conspiracy to commit subversion in connection with the 2020 Hong Kong pro-democracy primaries. Steven’s lay client was acquitted unanimously by a panel of designated judges after a trial lasting for 118 days.
