Insolvency and Bankruptcy Matters

- *Yeung So Lai (楊素麗) v. Art Excel Limited*, [2025] HKCA 957, successfully overturning the court below decision to set aside a statutory demand involving a debt exceeding HK\$120 million.
- *VPower Group Holdings Ltd v. CRRC Hong Kong Capital Management Co. Ltd*, [2025] HKCA 952, handling an injunction application to restrain the presentation of winding up petition against a subsidiary of a Hong Kong listed company.

- *Hu Lan (胡蘭) v David Golden (達偉)* [2024] HKCA 108 — successfully defending the defendant in a loan claim involving USD8.6 million both in the Court of First Instance and in the Court of Appeal.
- *Shown Wai Investment Company Limited v Hui Yip Wing David* [2024] HKCFI 1477 — successfully resisting a claim of breach of fiduciary duty made against the former CEO of the Chinachem Group.
