- *阮 v 黃* [2023] HKFC 149 – Represented the Respondent Father in successfully obtaining a split custody order in a children's trial.
- *LKY v OCF* [2022] HKFC 206 – Represented the Petitioner Wife in successfully obtaining a substantial award of maintenance pending suit after a contested interlocutory hearing.
